




### **AUCTION NOTICE**

Licence for collection of Itinerant Vendors Fees at Mount Festival at St. Thomas Mount from the itinerant vendors for two days only i.e., 17.12.2022 to 18.12.2022.

**TERMS / CONDITIONS**

1. The bidders shall deposit tender fee of Rs.1000/- (Rupees One Thousand Only) and Earnest Money Deposit of Rs.10,000/- (Ten Thousand Rupees Only ) through e-chhawani on 15-12-2022 and present the Earnest Money Deposit receipts at the time of auction.
2. The highest bidder has to deposit bid amount immediately after the closure of bidding. EMD will not be adjusted toward the bid amount. EMD will only be released after the completion of license period, subject to fulfillment of terms and conditions of license.
3. In case of failure by the highest bidder to deposit the highest bid amount, his earnest money will be forfeited and he will not be allowed to participate in the consequent public auction.
4. The highest bid amount quoted in the auction is for Two days only i.e 17.12.2022 and 18.12.2022.
5. The licensee has no right whatsoever on the property belonging to Cantonment Board.
6. The licensee has to collect Itinerant Vendors Fees from each vendor at Mount Festival at St. Thomas Mount.
7. The licensee has to collect Rs.100/- (Rupees One Hundred only) for those itinerant vendors, who occupy space of 8 feet frontage on the road side, and Rs.50/- (Rupees Fifty only) for small (less than 08 feet frontage) and mobile itinerant vendors.
8. The Licensee is not authorized to collect the Itinerant Vendor Fees before or after the specified dates. The EMD amount will be forfeited and the licensee will be banned from participating in any future tenders, if the Licensee found to be collecting the IV Fees on any other date other than the prescribed date.



9. Licensee has no right to collect any amount excess than prescribed above.
10. Licensee is responsible for peaceful collection of the fees during Mount Festival.
11. The Chief Executive Officer or any of his representatives have rights to check the correctness of collection at any time. In case, any overcharging incident/occurrence is detected with adequate proof, a penalty equal to 10 times the overcharge will be levied on the licensee, per incident/occurrence.
12. It shall be assumed that the bidders have read, understood and accepted all the terms and conditions of the auction once they participate in the bid.
